SECTION 21 - RETURNS POLICY (PRODUCTS)

At Battersea Park Clinic, we want to ensure your complete satisfaction with your purchase. If you are not entirely satisfied with your purchase, we are here to help. Please review our Returns Policy to understand your rights and responsibilities when returning items.

1. Returns Eligibility

You may return most new, unopened items within 6 days of delivery for a full refund. Returned items must be in their original condition, unused, and with all original packaging intact. Certain items, such as medallions and bracelets, are not eligible for return.

2. Return Process

To initiate a return, please follow these steps:

- Contact Battersea Park Clinic to request a Return label with a tracking code.
- Once you receive the label, securely package the item(s) and stick the label to the outside of the package.
- Ship the item(s) to us.
- Keep a record of the tracking number for your records.

3. Refund Policy

Once we receive the returned item(s) and inspect them, we will notify you of the approval or rejection of your refund.

If your return is approved, a full refund will be processed to the original payment method within 10 business days.

If the return is rejected due to non-compliance with our policy, we will contact you to discuss the next steps.

4. Warranty Claims

Items that arrive faulty or broken are covered by warranty for up to 48 hours. Please notify us so that we can resolve the issue.

5. Non-Returnable Items

Please note that the following items are not eligible for return:

- Medallions
- Bracelets

6. Shipping Costs

Shipping costs for returning items are the responsibility of the customer, except in cases where the return is due to an error on our part.

SECTION 22 - REFUND POLICY: SERVICES, BOOKINGS AND PACKAGES

Battersea Park Clinic ("we", "us", "the Clinic") wants every client to feel confident booking with us. This policy sets out how refunds, cancellations, and rescheduling work for treatments, sessions, and packages purchased at the Clinic or via our website.

1. Single Sessions and Standard-Priced Treatments

- Cancellations with 24 hours' notice or more: full refund or free rescheduling, your choice.
- Cancellations with less than 24 hours' notice: the session is non-refundable, but we will offer one complimentary rescheduling within 30 days, at our discretion.
- No-shows: non-refundable and non-reschedulable.
- Unused sessions within their validity period: if you are unable to use a booked, unstarted session and have given us reasonable notice, a refund may be issued at our discretion, minus any card processing fees.

2. Discounted Packages and Bundles

All discounted packages, course bundles, and promotional offers (including multi-session packages sold at a reduced rate versus individual session pricing) are final sale and non-refundable once purchased, except where required by law (see clause 5 below). This applies whether the package has been partially used, fully used, or not yet started. We are unable to offer partial refunds calculated at full/standard session pricing for any sessions already used within a discounted package.

Why: package pricing reflects a bulk discount extended in exchange for a committed, upfront purchase. Because the price per session is already reduced below our standard rate, we are not able to additionally refund at full value for unused sessions, as doing so would mean pricing the used sessions at less than cost. We encourage clients to purchase packages only when confident they can commit to using them within the validity period.

Where circumstances are exceptional (for example serious illness or injury preventing use of a package), please contact us. We consider such cases individually and may offer credit toward future treatments or an extension to the validity period, though this is offered

at our discretion and is not guaranteed.

3. Package Validity and Expiry

- Packages are valid for 12 months from the date of purchase unless otherwise stated at the time of sale.
- Expired, unused sessions are forfeited and non-refundable. Extensions may be granted at the Clinic's discretion in genuine cases of hardship.

4. Membership and Subscription Plans

- Rolling memberships may be cancelled at any time with 30 days' notice ahead of the next billing date.
- Payments already taken for the current billing period are non-refundable.

5. Your Legal Rights

Nothing in this policy affects your statutory rights. Under the Consumer Contracts Regulations, if you purchased online or by phone, you may have a 14-day cooling-off period on the purchase itself. However, this right is typically lost once a treatment has been booked for a specific date/time or once a service has begun, as you will have agreed to waive it in order to secure your appointment. Faulty, mis-sold, or materially different services remain eligible for remedy under the Consumer Rights Act 2015 regardless of the policy above.
